That we, the undersigned, for the purpose of forming a corporation under the laws of Missouri, relating to benevolent, religious, scientific, educational and miscellaneous associations under Article Ten, Chapter 33, of the Revised Statutes, 1939, in connection with others, have entered into the following atreement:

First: The name of this association shall be MISSOURI SCHOOL OF MINES TEKE, INCORPORATED.

Second: Its location shall be in Rolla, Phelps County, Missouri.

Third: Its duration shall be perpetual.

Fourth: This association is formed for the following purposes: to promote temperance, literary, historical, and scientific study of its members, and of the community; to promote the welfare, culture, and education of college students by acquiring and operating housing for such students on a non-profit basis; and to promote Christian ideals and loyalty to American democratic institutions. In order to effectuate the aforementioned purposes, the corporation may acquire, lease; hold, operate, convey and mortgage real and personal property, and may issue notes, bonds, and other evidences of indebtedness, all to the extent permitted by law and without profit.
